Change of Address Tips & Considerations



Landline Service Customers:

Accurate 911 service depends on accurate telephone company records. Notify your telephone company of your new address. This applies to residents wishing to establish land line service as well as those who already have landline service.

Mail/Parcel Service:

If you wish to establish mail delivery or parcel delivery at this address, you must notify the United States Postal Service (USPS). If you have not changed location, but have been readdressed at your current location please contact your local USPS office and provide them a copy of the **911 Address Verification Letter** you received from the County. Although the Postal Service may continue to deliver mail from your former address for a short time, it is recommended that you start using your new address immediately.

If you receive your mail at a post office box, your mailing address will not change. However, your location address for 911 purposes has changed to the address listed on the **911 Address Verification Letter**. You may choose to use your 911 address as part of your mailing address. If you do, the Postal Service requires the address to be placed in the order shown to the right.

Utility and Credit Card Bills:

Most companies provide an area on their billing statement for you to notify them of an address change, or have a self-service location on their website that allows you to update your address. If you have been readdressed at your current location it is recommended that you speak directly with your utility providers so they are aware that your location has not changed, despite your change of address.

PennDOT DMV:

Non-commercial Driver's License: You can change your address online or download and complete form **DL-80**, or form **DL-143** if license is within 6-months of expiration, and mail it to the address on the form.

Non-commercial Learner's Permit: You cannot change your address online for a learner's permit, instead you must download and complete form **DL-31**, and mail it to the address on the form.

Commercial Driver's License (CDL): You cannot change your address online for a CDL, instead you must download and complete form **DL-80CD**, or form **DL-143CD** if license is within 6-months of expiration, and mail it to the address on the form with all required documents and fees.

Vehicle/Trailer Registration and Title: You can change your address online or download and complete form **MV-63**, and mail it to the address on the form.

In addition to the self-service actions above many of these procedures can be handled at a local Driver's License Center. For more information about how to change your address with the DMV or to locate a Driver License Center, please visit PennDOT's website at www.dmv.state.pa.us.

Assessment Office:

The Blair County Assessment Office requires property owners to complete a **Change Of Address** form if their mailing address changes. The form is available in their office or online at: www.blairco.org/Dept/Assessment/Pages/Appeals
